

ADVERTISING ARTWORK

PREFERRED FORMAT: Adobe Acrobat, high-resolution, press-optimized, composite PDF.

Other acceptable formats include 300 dpi JPEG or TIF files saved in Photoshop.

Resolution: All PDFs must contain 300 dpi image files. Images with higher resolutions will be downsampled accordingly.
